MARE MUST BE ACCOMPANIED BY THIS FORM EVERY TRIP and HAVE PROPER ID (HALTER OR NECK STRAP) TO BE BRED!

Please check the mare's status below and attach a negative culture report if required.

- Domestic Maiden Mare** – *A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover. **ALL MAIDEN MARES MUST BE JUMPED (i.e., stand safely when mounted by a teaser stallion) BEFORE COMING TO THE BREEDING SHED.***
- Domestic Barren or Not Bred Mare** – *A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover.*
- Domestic Foaling Mare** (Date Foaled: ___/___/2016) – *No culture is required for the first cover. **However, if mare produced a foal that did not stand and nurse, a negative uterine culture is required.***
- Imported Maiden Mare** – *A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover. Mare must comply with 2014 USDA & Kentucky Department of Agriculture regulations. **ALL MAIDEN MARES MUST BE JUMPED (i.e., stand safely when mounted by a teaser stallion) BEFORE COMING TO THE BREEDING SHED. A COPY OF THE QUARANTINE RELEASE MUST ACCOMPANY THE MARE ON HER FIRST TRIP TO THE BREEDING SHED.***
- Imported Foaling or Barren Mare** – *Contact the KY State Veterinarian regarding testing procedures and acquisition of a quarantine release for the 2014 breeding season. **A COPY OF THE QUARANTINE RELEASE MUST ACCOMPANY THE MARE ON HER FIRST TRIP TO THE BREEDING SHED.** A negative uterine culture is required and must be taken within 30 days of the first cover but not later than 48 hours prior to the first cover.*
- Returning Foaling Mare (2nd heat cycle)** – *A negative culture required.*
- Returning Barren or not Bred Mare (3rd and all subsequent heat cycles)** – *A negative uterine culture is required and must be taken within 30 days of the third cover but not later than 48 hours prior to the third cover.*

This mare has been vaccinated for EHV1 from in the last 7-90 days.
